

PROMOTION RULES

Your Summer Vacation Could Be on Us!

1. DEFINITIONS

1.1 *Your Summer Vacation Could Be on Us!* (hereafter referred to as the “Promotion”):

Promotion held per the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).

1.2 **Loto-Québec:**

Présidence des opérations – Loteries (hereafter referred to as “POL”), on behalf of the Société des loteries du Québec, the organization responsible for the Promotion.

2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided they have an Espacejeux account on lotoquebec.com and confirmed their identity according to applicable terms, are residents of Québec and not registered in a self-exclusion program operated by Loto-Québec through its online gaming site, gaming halls or casinos.

3. DURATION OF THE PROMOTION

The Promotion will run from 9 a.m. on July 1, 2019, to 11:59:59 p.m. on July 21, 2019.

4. HOW TO ENTER

4.1 To take part in the Promotion, eligible entrants must first register by entering promo code ABLOT4035 where indicated in their Espacejeux account during the Promotion period. Each eligible entrant can only register once (1) during the entire Promotion period.

To enter the promo code, first click My Account, located in the upper right-hand corner of the screen, then My Promotions in the menu at the left.

4.2 Once duly registered in accordance with Section 3.1, entrants eligible for the Promotion will automatically receive one (1) entry for the draw described in Section 4 of the rules herein, provided they have an active lottery subscription on loto-quebec.com at the time of the draw. Only one (1) entry per eligible entrant is allowed.

5. DRAW AND PRIZE DESCRIPTION

- 5.1** The Promotion's random electronic draw among all entries duly registered in compliance with the rules herein will be conducted on July 22, 2019, at the Société des loteries du Québec's head office in Montréal using Loto-Québec's computer system in order to determine one (1) Promotion winner.
- 5.2** The draw will be conducted and supervised by authorized Loto-Québec representatives.

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT:

- 5.3** In the event that the entry drawn is deemed valid and compliant with the rules herein, the winner will receive a cheque for two thousand five hundred dollars (\$2,500) as well as an orange-coloured suitcase filled with vacation items worth approximately two hundred and fifty dollars (\$250). The summer-themed items in the suitcase will be worth between \$10 and \$50 each and selected by the POL.

IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED INVALID OR NON-COMPLIANT:

- 5.4** Should the entry drawn be deemed invalid or non-compliant with the rules herein, another entry will be drawn at random. Such draws will take place until an entry is found to be valid and compliant, in which case the terms described in Section 5.3 **IN THE EVENT THAT THE ENTRY DRAWN IS DEEMED VALID AND COMPLIANT** above will apply.

6. PRIZE REMITTANCE

A POL staff member will contact the winner designated in accordance with Section 5 herein to confirm the win and provide the terms for claiming the prize. The winner will have forty-eight (48) hours to confirm acceptance of the prize awarded, failing which they will not be entitled to the prize or any compensation of any kind whatsoever, and another entry will be drawn at random in accordance with Section 5.4.

The POL can require the winner to show a valid form of government-issued photo ID before remitting the prize. Once the winner's identity has been checked and confirmed and the winner has complied with the rules herein, the prize described in Section 5 of the rules herein will be awarded according to the terms indicated by the POL.

7. NAME, ADDRESS, PHOTOGRAPH AND VIDEO

The name, address, photograph and video of the winner, and any other information voluntarily provided, can be used by Loto-Québec and its subsidiaries not only for the draw described in the rules herein, but also for advertising purposes, particularly on the Internet (including social media). The winner must waive all rights to compensation related to broadcasting, printed material and advertising.

8. OTHER RESTRICTIONS

- 7.1** The prize must be accepted "as is" and cannot be converted to cash or transferred.
- 7.2** The POL reserves the right to replace the prize, in whole or in part, with another of equal value.
- 7.3** No compensation will be paid to a winner who cannot use the prize.
- 7.4** The POL reserves the right to cancel or delay the Promotion, in whole or in part, for any reason whatsoever or due to an act of God or force majeure.
- 7.5** The POL declines all responsibility toward anyone should the Promotion be delayed, cancelled or amended, or in the event of computer equipment breakdown or malfunction.
- 7.6** In the event that an entrant violates the rules herein, makes a false statement, attempts to cheat, commits fraud, acts in collusion or conspires with a third party, their entry will automatically be rejected and they will be ineligible for any other event related to the Promotion.
- 7.7** The POL can also amend the rules herein at any time, in which case revised rules will be made available to the public.
- 7.8** The POL declines all responsibility towards anyone who has not received one or more electronic entries or a chance to participate in the Promotion.
- 7.9** The POL declines all responsibility in the event of any situation, incident or any other occurrence that prevents anyone from meeting Promotion deadlines or confirming acceptance of a prize within prescribed deadlines.
- 7.10** A winner who is registered in a self-exclusion program operated by Loto-Québec through its online gaming site, gaming halls or casinos at the time a prize is claimed will not be entitled to receive said prize.

9. DISPUTES

Eligible persons agree to comply with the rules herein as well as all other applicable rules and conditions indicated on lotoquebec.com. Any dispute relating to this Promotion, whether regarding conduct and/or award of any prizes, will be settled according to the rules herein and the Sales promotion games By-law (CQLR, c. S – 13.1, r. 4).
