

## PROMOTION RULES

### *Lottery Subscription*

---

#### 1. DEFINITIONS

**1.1. *Lottery Subscription Promotion*** (hereinafter the “**Promotion**”):

Promotion held pursuant to the *Sales promotion games By-law* (CQLR, c S-13.1, r. 4).

**1.2. Loto-Québec:**

The Société des loteries du Québec, the party responsible for organizing the Promotion.

#### 2. ELIGIBILITY

Only individuals who are eighteen (18) years of age or older can enter the Promotion, provided they have an account on Loto-Québec’s gaming website, [lotoquebec.com](http://lotoquebec.com), and their identity has been confirmed according to the applicable terms and conditions. In addition, they must not be self-excluded from a casino, gaming hall or [lotoquebec.com](http://lotoquebec.com), nor must they be barred from casinos, gaming halls or [lotoquebec.com](http://lotoquebec.com).

#### 3. DURATION OF THE PROMOTION

The Promotion will run from May 1, 2024, at midnight, until May 31, 2024, at 11:59:59 p.m.

#### 4. HOW TO ENTER

**4.1.** Eligible individuals will automatically receive one (1) entry in the draw described in Section 5 of these rules, for each of their lottery subscriptions on [lotoquebec.com](http://lotoquebec.com), provided that the subscription is active as of the end date of the Promotion.

**4.2.** There is no limit to the number of entries each eligible individual can earn during the promotion period.

#### 5. DRAW AND PRIZE DESCRIPTION

**5.1.** The Promotion draw will take place on June 5, 2024, in the form of an electronic draw from all the entries duly received, in accordance with the rules herein and conducted using Loto-Québec’s computer system at Loto-Québec’s head office in Montréal. Twenty-five (25) winners will be drawn.

**5.2.** The draw will be conducted and supervised by authorized Loto-Québec representatives.

**IN THE EVENT THAT THE SELECTED ENTRIES ARE VALID AND COMPLY WITH THESE RULES:**

- 5.3.** In the event that the selected entries are valid and comply with these rules, each winner will win the amount that their winning subscription cost them during the month of the Promotion. The amount will be deposited directly into their [lotoquebec.com](http://lotoquebec.com) account<sup>1</sup>, in accordance with the terms of Section 6.

**IN THE EVENT THAT A SELECTED ENTRY IS NOT VALID AND DOES NOT COMPLY WITH THESE RULES:**

- 5.4.** An entry will be void if it is not valid or does not comply with these rules, or if the entrant fails to comply with the terms and conditions hereof. If applicable, a new entry will be drawn at random until a valid entry that complies with these rules is drawn, in which case the terms and conditions in Section 5.3 will apply.

**6. PRIZE FULFILLMENT**

The winners, designated in accordance with Section 5 of these rules, will be contacted by email or phone by a member of Loto-Québec's staff, who will inform them that they have won a prize and that it will be deposited into their account on [lotoquebec.com](http://lotoquebec.com).

When the winners claim their prize, Loto-Québec may require that they show a valid form of government-issued photo ID. Once the winners' identity has been checked and confirmed, and their compliance with these rules has been attested, they will receive their prize, as described in Section 5 of these rules and in accordance with the terms and conditions set out by Loto-Québec.

**7. NAME, ADDRESS AND PHOTOGRAPH**

All winners consent to Loto-Québec and its subsidiaries publishing their name, region and photograph if Loto-Québec deems it appropriate. In addition, entrants hereby acknowledge and accept that their name, pseudonym, region, photograph, video in which they appear (compliant with Loto-Québec standards) and any other information they provide may be used by Loto-Québec and its subsidiaries for the purposes of both the draws provided herein and advertising or promotional initiatives, in particular on the Internet (including on social media and [lotoquebec.com](http://lotoquebec.com)'s promotional and winners pages). No rights to broadcasting, printed material or advertising can be claimed in this regard.

**8. OTHER RESTRICTIONS**

- 8.1.** Prizes are limited to one (1) prize per eligible entrant for the duration of the Promotion.
- 8.2.** Prizes must be accepted as is and can be withdrawn for cash but cannot be exchanged or transferred.
- 8.3.** Loto-Québec reserves the right to substitute a prize for another one of equal value.
- 8.4.** Loto-Québec reserves the right to cancel the Promotion, in whole or in part, or postpone it for any reason whatsoever, including cases of fortuitous events or *force majeure*. Loto-

<sup>1</sup> The cash prize will automatically be deposited into the winner's account on [lotoquebec.com](http://lotoquebec.com) approximately seventy-two (72) hours after the draw. The money can be used to play any game on [lotoquebec.com](http://lotoquebec.com). It may be withdrawn for cash but cannot be exchanged or transferred.

Québec may also amend these rules at any time, in which case the amended rules will be made available to the public.

- 8.5.** Loto-Québec declines all liability towards anyone should the Promotion be cancelled, postponed or amended, or in the event of a computer system failure or malfunction.
- 8.6.** Loto-Québec declines all liability towards anyone who may not have received their electronic entry (or entries) or earned the right to enter the Promotion.
- 8.7.** Loto-Québec declines all liability in the event of any situation, incident or other occurrence that prevents anyone from meeting entry deadlines or claiming their prize.
- 8.8.** No individual may be declared a winner nor claim their prize if, at the time of the draw: 1) they are self-excluded from a casino, gaming hall or lotoquebec.com, 2) they are barred from casinos, gaming halls or lotoquebec.com.
- 8.9.** Should an entrant fail to comply with these rules, make a false statement, attempt to cheat, commit fraud, act in collusion or conspire with a third party, their entry will automatically be void, and they will be disqualified from further participation in any event related to the Promotion.

## **9. DISPUTES**

Eligible individuals agree to abide by these rules and all other applicable rules and conditions stated on the lotoquebec.com website. Any dispute related to the management of the Promotion and awarding of prizes will be settled according to these rules and the *Sales promotion games By-law* (CQLR, c S-13.1, r. 4).
